## **Appendix / Punishment Catalogue**

The following regulations and rules are determined for the Players of the Challenger Series:

### **§1 Mobile Phones/Notebooks/Laptops/Tablets**

Any usage of mobile phones, notebooks, laptops or tablets in the court area is not allowed! For every disregarding of this regulation the player must pay a penalty of 50 Euro.

### **§2 Order in the venue/hall**

The player must keep the venue clean which includes the followings:

- clean up the table after eating
- the clothes must be dried at the marked area (NOT OUTSIDE THE HALL)
- don't leave any belongings in the hall because any of them will be thrown out after the tournament

### **§3 Rules of Hotel Mohren**

We would like to emphasize that Hotel Mohren is our partner and doesn't belong to us. Because of previous misunderstandings the new rules are applied:

- NO TOWELS from Hotel Mohren are allowed to be used during the matches otherwise 25 Euro penalty must be paid; if we find a towel after the tournament is finished, the penalty will be deducted at the next tournament
- ROOM KEYS must be left on the reception desk on the day of departure otherwise returning the key to Hotel Mohren costs 25 Euro
- ANY EXTRA SERVICE (for example extra night) must be paid before leaving. Failure to do so will result in rejecting to book an additional night for the upcoming tournaments.

### **§4 Respond to emails**

Every player is obliged to respond to the emails which she/he receives from the Challenger Series, especially to emails regarding the arrival. The player must respond to the Invitation email until the given deadline. By disregarding this rule the player must pay a penalty of 50 Euro and she/he needs to organize and pay her/his own pick up.

## §5 Cancellation

In case of injury or any other health problems the player can cancel the participation of Challenger Series by showing a medical certificate at any time. In any other case the player needs to pay a penalty as follows:

- 1 day after the given deadline\*: 50 Euro
- 2 days after the given deadline\*: 100 Euro
- 3 days after the given deadline\*: 150 Euro
- 4 days after the given deadline\*: 200 Euro
- 5 days after the given deadline\*: 250 Euro

\* the deadline defined in the invitation

If a player wants to cancel his participation during the tournament without being able to show a medical certificate, the prize money will not be paid.

## §6 Behavior

Because of some previous regrettable issues, we renew our rules of behavior with specific regard to the games. Yellow card will be given in the following issues (these card penalties will hold up until the end of the tournament):

- throwing the racket against any inventories of the Challenger Series (table, floor, wall etc.)
- kicking the table with legs or hands
- shouting loudly and heavily continuously
- leaving the hall between two sets
- throwing out the ball from the court

Yellow card penalties will be given as follows:

1st	20 Euro
2nd	70 Euro
3rd	120 Euro
4th	170 Euro
5th	220 Euro

In addition, off the table verbal abuses will be punished by 50 Euro.

Damages to Challenger Series equipment will be paid by the causing player.
