## **Appendix / Punishment Catalogue**

The following regulations and rules are determined for the Players of the Challenger Series from 01.01.2025 onwards:

### **§1 Mobile Phones/Notebooks/Laptops/Tablets**

Any usage of mobile phones, notebooks, laptops or tablets in the court area is not allowed! For every disregarding of this regulation the player must pay a penalty of 50 Euro.

### **§2 Order in the venue/hall**

The player must keep the venue clean, which includes the following:

- clean up the table after eating
- the clothes must be dried in the marked area (NOT OUTSIDE THE HALL)
- don't leave any belongings in the hall because any of them will be thrown out after the tournament

### **§3 Rules of Hotel Mohren (Notice in Players' Lounge)**

We would like to emphasize that Hotel Mohren is our partner and doesn't belong to us. Because of previous misunderstandings the new rules are applied:

**Check out time on Tuesday/Friday at the hotel is 11:00 am**

#### **LATE CHECK OUT:**

In the case you want to use the room longer, you need to ask in advance at the reception in the Hotel for Late Check out and pay directly to the hotel.

#### **EXTENDED STAY:**

In the case you want to stay till the next tournament/ an extra night you need to check with the hotel in advance if it is available and pay the extra night to the hotel.

#### **TOWELS/ROOM KEY:**

In the case you take towels or the key from hotel you need to return them after the tournament immediately. Otherwise, you bought it, and this will be charged.

#### **EXTRAS:**

Extra services like the mini bar, food, beverages you must pay by yourself at the reception before Check Out.

Any disregard of the above mentioned we submit from your price money and charge you an additional €50, - as penalty fee.

#### **§4 Behavior**

Yellow cards will be given in the following issues (these card penalties will hold up until the end of the tournament):

- throwing the racket against any inventories of the Challenger Series (table, floor, wall etc.)
- kicking the table with legs or hands
- shouting loudly and heavily continuously
- leaving the hall between two sets
- throwing out the ball from the court

Yellow card penalties will be given as follows:

1. 20 Euro
2. 70 Euro
3. 120 Euro
4. 170 Euro
5. 220 Euro

In addition, off the table verbal abuse will be punished by 50 Euro.

Damages to Challenger Series equipment will be paid for by the causing player
